Section: Salaried Certificated/Licensed Administrator Titles

Move the Administrator of School Based Prevention and Counseling position from 260 Day Certificated/Licensed Administrators to 220 Day Certificated/Licensed Administrators

Move the School Psychologist position from Tiered Benefit Group 5 to Tiered Benefit Group 4

Section: Salary Procedures

Update paragraph in A-1 to read: In order to facilitate the migration to the new salary schedules contained in this handbook, for the 2021-2022 School Year, Administrators will be placed at the closest step to their FY21 salary.

2. Salary Base Increase

Approve a 2% base wage increase for the 2021-2022 school year to administrators who opted out of a newly offered contract aligned with the

Licensed/Certificated and Classified Administrator Wage and Benefits Guidelines.

3. Decrease in Contract Time – Administrative Employee
